Al+Clear® Dry

Original Al+Clear® product, developed in 1997. Works best in damp environment by using hydrolysis to dry pads or litter while lowering the pH, controlling ammonia and binding phosphorus. Safe to apply with birds in the house.

Al+Clear® A7

Second generation liquid product which has extended ammonia control, reduces litter moisture and pH as well as binds phosphorus. Product activates in dry conditions and is custom applied.

Al+Clear® Xtra

Second generation dry crystallized product is designed to have immediate activation to reduce ammonia levels and lower pH when litter conditions are dry. Flexible application window up to 2 days prior to bird placement and is safe to apply with birds in the house.
