Our meeting will be held virtually (on-line) this year due to the COVID-19 pandemic and on-going concerns about in-person gatherings. We encourage you to attend the virtual meeting. How to get a copy of this year's management information circular

If you are a registered unitholder or you have given us instructions to send you printed documents, your management circular is enclosed with this notice.

We are using the *notice and access* method to deliver our meeting materials (this notice, our management information circular and our 2021 annual financial statements, annual management's discussion and analysis and auditors' report) to non-registered (beneficial) unitholders for our 2022 annual meeting. Notice and access is a set of rules developed by the Canadian securities regulators that allows issuers to provide online access to materials instead of sending paper copies, reducing paper and mailing costs.

We have also elected to use procedures known as 'stratification' in relation to our use of the notice and access method. In relation to our 2022 annual meeting, non-registered (beneficial) unitholders holding greater than 5,000 units will receive a paper copy of this notice, our management information circular and our 2021 annual financial statements, annual management's discussion and analysis and auditors' report whereas non-registered (beneficial) unitholders holding less than 5,000 units will still receive a voting instruction form or form of proxy in the mail to vote your units, as well as a notice with instructions on how to access and view the electronic copy of our information circular and annual report.

If you have not provided standing instructions to receive printed documents by mail, we have sent you this notification, along with either a proxy form or voting instruction form, so you can provide your voting instructions. **Please view the management information circular before voting.**
